2006 National Verger Conference at Sea

**Reflections on the 18th Annual Conference
The Verger's Guild of the Episcopal Church
Boca Raton FL, Miami, FL and Nassau, The Bahamas
November 9-13, 2006**

I always look forward to attending the National Verger's Conference that is traditionally held in September/October each year. This was my third conference! Certainly, I'm not setting any records, but I'm getting to know and easily recognize vergers from TN, Washington, New York, New Mexico etc. This year there were 22 states and Canada represented. For some it was their first conference, for others it was their 18th!



Holding a conference on a cruise ship was certainly a unique venue. It took giant coordination to pull it all together. We began our five days together in Boca Raton, FL at Evensong at St. Gregory's and a dinner provided by their youth group that rivaled any upscale restaurant. An early morning departure took us to the Duncan Center, Delray Beach, FL for Morning Prayer, St. Bernard de Clairvaux Church and Trinity Episcopal Cathedral, Miami. Each was wonderfully historical providing us with the spirituality and historical significance of our liturgy.

By the time we had boarded the cruise ship late Friday afternoon, vergers had already networked with each other, sharing church history, verger minutia, acolyte customaries, and family fun stories. What we all commonly share is our commitment and love of our ministry.

The remainder of the cruise was filled with a workshop every evening which left us time during the day to enjoy what the cruise had to offer. The workshops were outstanding; three days, three workshops: Fr. Andrew Sherman, Rector St. Gregory's Church presented "Images of Vergers in Scripture", Mr. Brian W. Davey, Organist and Choir Master, St. Gregory's Church and Ms. Jean Maceachron, Soloist presented "Today's Many Liturgical Musical Styles", and our keynote speaker was Bishop Leo Frade, Bishop of Southeast Florida. He spoke on "The Cultural Differences in the Liturgy". In addition to Fr. Sherman and Bishop Frade, Fr. Stuart Hoke, Chaplain of the VGEC joined us on the cruise, gave a wonderful homily at Morning Prayer and assisted at our beach Eucharist.

It was noted by our ship's captain that the weather on our cruise was the best weather they had had in two weeks. We all thought that 72 vergers, 2 priests, a deacon, and a bishop might have helped. Two final highlights were held on the islands of Coco Cay and Nassau. Bishop Frade was the celebrant of Eucharist on the beach at Coco Cay. Holy vessels were hand-carried from the mainland, a table was set with a white cloth, and a lawn chair served well for the credence table. Even a small member of the island livestock shared the occasion. As we sat on the sandy beach, a chicken made his way through the legs, arms and beach chairs.

The second most memorable day was Sunday's attendance and Eucharist at St. Agnes Parish, Nassau. Founded in 1845, St. Agnes is a landmark and beacon of higher praise in New Providence. A steadfast institution of faith, St. Agnes and its parishioners are on a mission to create tighter bonds between the church and its surrounding Grant's Town Community.

Our final evening together was a celebration of our ministry, our fellowship and to honor vergers who have completed the extensive VGEC Training Course. As we left the ship the following morning, we pledged to stay in touch, renew our strong commitment to our ministry and look forward with great anticipation to the 2007 conference in Albuquerque, NM.

Proposed Bylaw Changes, December 2006

These bylaw changes will be discussed and voted on at the January 2007 Quarterly Meeting. Please come prepared to discuss these changes.

ARTICLE IV: OFFICERS

Current Wording

- Section 1** The officers shall be the President, Vice President, Secretary/Treasurer, Training Officer, and Communications Officer
- Section 2** In the spring of each even-numbered year, the above officers shall be elected by mail-in ballots.
- Section 2A** Nominations shall be solicited in written form (including electronic mail and/or the newsletter) at least two months prior to the election, and shall include descriptions of the offices to be filled.
- Section 2B** Written nominations, each accompanied by the signed acceptance of the candidate, must be received by the Vice President at least one month prior to the election, and shall include descriptions of the offices to be filled.
- Section 2C** Ballots listing the candidates will be sent to all voting members of the Chapter, and must be returned to the Vice President prior to the official election date.
- Section 2D** For each office the candidate securing the largest number of votes shall be elected. If no one secures more than half the votes, a second election will be held to fill that office.
- Section 3** The Board shall be elected by ballot to serve for a two year term or until their successors are elected. The election shall be by 50% plus one of the Guild members voting. Their terms of office shall begin at the close of the meeting.
- Section 4** The President and Vice President may be re-elected to serve in the same office for no more than two successive terms. The President and Vice President shall not be eligible for re-election to the office of President or Vice President until after a duration of two years beyond their last term.

Proposed Wording

- Section 1** The officers shall be the President, Vice President, Secretary/Treasurer, Training Officer/Churches, Training Officer/Seminars, and Communications Officer.

- Section 2** In the spring of each year, commencing in 2008, half of the above officers shall be elected.
- Section 2A** Nominations shall be solicited in written form (including electronic mail and/or the newsletter) by the Nominating Committee at least two months prior to the election, and shall include descriptions of the offices to be filled.
- Section 2B** *delete*
- Section 2C** Ballots listing the candidates will be handed or mailed to all voting members of the Chapter, and must be returned to the Nominating Committee chair prior to the official election date or at the election meeting.
- Section 2D, Section 3, and Section 4** *No changes from the above are proposed*
- Section 5** Commencing in 2008, Vice-President, Secretary/Treasurer, and Training Officer/Seminars will stand for election; in 2009 the President, Training Officer/Churches and Communications Officer will stand for election.

ARTICLE VI: EXECUTIVE BOARD

Current Wording

- Section 1** The officers of the Chapter shall constitute the Executive Board.
- Section 2** The Executive Board shall have general supervision of the affairs of the Chapter between its business meetings, fix the hour and place of meetings, make recommendations, and shall perform such other duties as are specified in these bylaws. The Board shall be subject to the orders of the Guild, and none of its acts shall conflict with action taken by the Guild.
- Section 3** Special meetings of the Executive Board can be called by the President, and shall be called upon the written request of two members of the Board.

Proposed Wording

- Section 1** The officers of the Chapter shall constitute the Executive Board, and may appoint up to four Full members (past officers, members with corporate memory, or members with special skills, etc.) to join the Executive Board in an advisory capacity.
- Section 2 and Section 3** *No changes from the above are proposed*
- Section 4** In the event of the dissolution of the Chapter, the Executive Board shall disperse the funds remaining in the treasury, to an Episcopal charity or institution.

ARTICLE VII DUTIES

Current Wording

- Section 1** The President shall preside at all general meetings and meetings of the Executive Board. The President shall represent the Chapter at official functions, shall serve as Bishop's Verger if requested, and shall otherwise promote the office of Verger throughout the Diocese.
- Section 1A** In the absence of a representative of the Guild, the President shall attend and conduct the installations of vergers of the Diocese. The President may delegate this duty to another officer of the Chapter.
- Section 1B** The President shall appoint committees as needed.
- Section 1C** The Executive Board shall appoint, or renew the appointment, of the Chaplain within one month after each general election. The length of time a Chaplain may serve is to be determined by the wisdom of the Board.
- Section 2** The Vice President will preside in the absence of the President. In the case of a vacancy in the office of President, the Vice President shall serve until the next election of officers and shall be eligible for the office of President.
- Section 3** The Chaplain shall serve as spiritual director, advisor, and liturgical consultant for the Chapter.
- Section 4** The Training Officer shall plan programs for the regular meetings and coordinate other training events with the President.

- Section 4A** An Assistant Training Officer may be appointed by the Training Officer with confirmation by the Executive Board.
- Section 5** The Communications Officer will assist the Vice President in communications to the membership and the church at large.
- Section 6** The Secretary/Treasurer will record the minutes of meetings, handle Chapter correspondence and serve as financial officer of the Chapter.
- Section 7** Vacancies in office other than the President will be filled by the Executive Board.

Proposed Wording

Section 1, Section 1A, Section 5 and Section 6 *No changes from the above are proposed*

Section 1B The Executive Board may appoint duties to non-elected positions, such as Regional Training Officers, Nominating Committee, Publicity, Public Relations, Parliamentarian, etc., as deemed necessary.

Section 1C The Executive Board shall appoint, or renew the appointments of Chaplains as soon as is practicable after each general election. The length of time each Chaplain may serve is to be determined by the wisdom of the Board.

Section 2 The Vice President will preside in the absence of the President. In the case of a vacancy in the office of President, the Vice President shall serve until the next election of officers and shall be eligible for the office of President.

Section 3 The Chaplains shall serve as spiritual directors, advisors and liturgical consultants for the Chapter.

Section 4 The Training Office /Seminars shall plan programs for the regular meetings and coordinate other training events with the Executive Board, particularly the Training Seminar.

Section 4A The Training Officer/Churches shall nominate and train Regional Training Officers and others to be trainers, and work with clergy to recruit and train new vergers.

Section 7 Vacancies in office other than the President shall be filled by appointment of the Executive Board.

Section 8 The Chaplains shall be responsible for prayers at all meetings, write columns for each issue of the newsletter, and serve as mediators in difficult situations.

ARTICLE IX AMENDMENT OF BYLAWS

Current Wording

These bylaws can be amended at any regular meeting of the Chapter by a two-thirds vote, provided that the amendment has been submitted in writing at the previous regular meeting.

Proposed Wording

These bylaws can be amended at any regular meeting of the Chapter by a two-thirds vote, provided that the Executive Board recommends the change or the amendment has been submitted in writing to the attendees at the previous regular meeting.

The National Course

Have you ever thought about taking the National Course for vergers training? Have you wondered if it was worth the cost and time to complete the coursework? The Diocese of Texas has two vergers, Peggy Metcalf of St. Marks Houston and Bob Bliss of Grace Church Georgetown, who have completed the requirements and are Fellows of the VGEC. The coursework is much like graduate level work requiring a lot of reading, practical work and writing. Upon completion of the course you will have a well rounded perspective of the knowledge required of a verger.

The reading list is comprehensive and very worthwhile. A Priests Handbook, The Book of Occasional Services, and The Book of Lesser Feasts and Fasts are a must in a vergers library. They, in conjunction with the Book of Common Prayer, are the backbone of the way services are conducted. In addition you will be required to read books on church history, the altar guild, church music, crafting liturgy, and history of the American Prayer Book. There is also a very good book by Ormande Plater, *The Deacon in the Liturgy*, which outlines the role of the Deacon during our Liturgy.

It is recommended to complete an entire church year cycle and capture the specifics of each type service in writing. From these notes and checklists the most important aspect of the coursework is produced, your own customary tailored to your congregation and the vision of the rector. The customary will contain everything needed to perform both regular services and services on special occasions. It is an essential document both for the vergers and other lay ministries. It is also a large portion of the document that is submitted for review by a board of assessors.

The course is comprehensive and requires dedication on the part of the student to complete but is very worthwhile. No one is going to watch over your shoulder and give you deadlines. It is all self paced and can get as detailed as you want. It really is up to you. You'll get out of it what you put into it but if you spend the time you will be rewarded with a greater understanding of what a verger needs to be capable of doing. The last thing that is required is to plan and write a Special Service that differs from your usual Sunday Morning worship. Some also plan an installation service for the Installation of a Verger.
